## RESTRUCTURING Industrial lithium-ion batteries division

Offenbach, 29 August 2019

Dear business partners,

We are pleased to inform you that recycling of device and household batteries will resume at our Offenbach am Main site on 2 September 2019. Thank you for the confidence, support and loyalty that you have shown us since the fire in May 2019.

The fire will, however, have some impacts on the industrial lithium-ion batteries division: Working in close cooperation with the regional council for Darmstadt and the town of Offenbach am Main, we have determined that we will no longer be able to accept industrial lithium-ion batteries at our Offenbach site with immediate effect.

Taking into account this new local authority regulation and our focus on the safety of our employees, the community and environment, we will be working with our parent company Saubermacher to newly configure the industrial lithium-ion batteries division. While the regulatory requirements and restructuring will temporarily limit production capacity, we will continue to meet our contractual obligations. To this end, we will be in personal contact with our contract customers in the next few days.

Work on a future-proof solution for the recycling of industrial lithium-ion batteries is already well under way, and the needs of our customers remain firmly at the heart of our endeavours. We anticipate that a full or additional recycling service will be up and running again from the fourth quarter of 2020.
